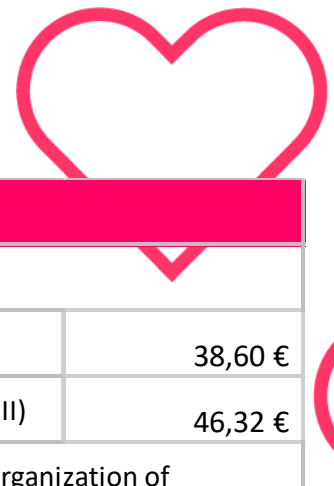

Cancellations must be made 12 hours before the booked appointment time.

Travel costs	
Travel, accommodation, travel time and daily allowances are charged separately.

Reimbursement for preventive occupational health care (Category I) is 60 % and for medical services (Class II) 50 % of the approved costs.
